Should the initial employment occur after the annual filing period, the initial report must be filed with the City Clerk within fifteen (15) days of such initial employment.

Any changes to the registration information after the annual registration period, including but not limited to the legislative or administrative action for the City of Santa Rosa as to which the lobbyist has been engaged or the addition or loss of a client, shall require the filing of an amended registration with the City Clerk within fifteen (15) days of such changed information.
